





Decrease in 2008 Bank Balance is mostly due to S3000 moved from checking to a CD during that year. Increase in 2009 Sales Tax reflects S313.30 of 2008 taxes paid in 2009. Increase in Seed Bank Expenses for 2009 reflects S350.50 spent on seeds. Increase in Web Site expenses reflects several years of back hosting fees paid during 2009.
